



## **DirectLoop T.E.A.M.S Roping format: NO NUMBERS REQUIRED/All Ropers Welcome**

Licensed and protected under US PATENT #7066850 Dewaine and Linda Carlsen patent owners

- \* DirectLoop will produce all roping flyers and ads for producer
- \* Producer will pay \$1 per team licensing fee, and \$1 per team for the use of the DirectLoop T.E.A.M.S format.
- \* All ropings will be pick 1 draw 2 or draw all 3 for \$100  
Enter twice for 6 partners. Or a combination of pick and draw formats, not to exceed more than 2 pick partners or a total of 6 partners.
- \* All ropings will be 4 steer average, 10 second barrier and flagged on the face.
- \* No more than 1/3 stock charge will be assessed by producer.
- \* After 3<sup>rd</sup> round is finished the total teams to catch 3 will be equally divided into a 4 tier payoff round, from the fastest to the slowest. If the total number of teams to catch 3 steers is not divisible by 4, the extra runs will be added to the upper level tiers.
- \* All ropings will have a multi-tier cash payoff as follows:  
  
80 total teams or less 1 places per tier (4 tier)  
100-120 teams 2 places per tier (4 tier)  
121-160 teams 3 places per tier (4 tier)  
161-200 teams 4 places per tier (4 tier)  
201-240 teams 5 places per tier (4 tier)  
241-280 teams 6 places per tier (4 tier)
- \* All ropings will have prizes for all payoff round qualifiers who do not place in the average, up to 5<sup>th</sup> place. Producer will be responsible for first two prizes which must be purchased from DirectLoop, balance of prizes will be provided by DirectLoop.

\* Winners from each tier will come back for a winner take all Bonus round. Teams will switch partners, 1st tier header will rope with 4<sup>th</sup> tier heeler and vice versa winners from tiers 2 and 3 will trade partners. Winners will receive bonus prizes at the discretion of the producer.

\* DirectLoop T.E.A.M.S Roping will have a Qualifier Finals in Sept of 2010 in Pocatello, ID

\* Ropers must be a member of DirectLoop T.E.A.M.S Roping to be eligible to qualify to rope at the finals. Membership will be \$45.00 per calendar year (Jan 1<sup>st</sup> thru Dec 31<sup>st</sup>) Non-members will be allowed to rope at any T.E.A.M.S roping by paying a \$10 non-member fee per event. All non-member fees collected by the producer are to be paid to DirectLoop, LLC.

\* Every roper entering a DirectLoop T.E.A.M.S roping will be required to fill out a membership/release form prior to roping. Producer will be required to provide completed forms and fees to DirectLoop upon settlement.

\* Producer will keep \$10 per membership sold at their ropings, \$15 will be used for awards and or added money for the finals, and \$20 will go to DirectLoop for admin fees. All new members who join will be enrolled under the producer who sold them their membership, that producer will be eligible to earn cash commissions and bonuses on those members purchases in DirectLoop buyers club

\* No time will be given if the steer steps in the head loop with a front leg.

\* Cross fire rule will be observed. Steer must be completely switched and in tow before the heel loop can be thrown.
